# 101. A Bill to Promote the Hunting of Specific Invasive Species to Protect the Native Wildlife and American Agricultural Interests

---

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 1 SECTION 1. All states containing more than 50,000 of one of the encompassed invasive species will be  
2 required to set up, at minimum, 3 "Invasive Turn-in Centers", which will hereby be referred to as  
3 ITCs. Anybody who kills a wild, undomesticated, not breezed invasive creature will be rewarded.  
4 This amount is determined by what animal is turned in, with 5 different levels of reward as  
5 shown in section 2. ITCs will only give the reward money if the corpse of the creature is turned in,  
6 and if photo or video evidence is provided proving the animal was hunted in the wild.
- 7 SECTION 2. To elaborate on the different rewards per animal, all animals will be ranked with a [0] [1] [2] [3]  
8 or [4] to correspond with reward money received on turn in; [0] is 50 dollars per 50 turnt in, [1] is  
9 \$25 for one animal turned in, [2] \$100 for single animal turn in [3] \$150 for single animal turn in,  
10 and finally [4] \$250 for single animal turn in. "Invasive species" are any animal that are foreign to  
11 the environment in which they are in and are only in the Americas due to human intervention.  
12 However, this bill only encompasses the following invasive animals: [0] Spotted Lanternfly  
13 (*Lycorma delicatula*) [2] Feral Swine (*Sus swof*), [2] Burmese Python (*Python bivittatus*), [1]  
14 European Starlings, (*Sturnus vulgaris*), and [4] Nile Crocodiles (*Crocodylus niloticus*). This list may  
15 also be expanded with further legislation. "Invasive Turn-in Centers" will be any building used for  
16 the express purpose of citizens redeeming reward money for hunting invasive species.
- 17 SECTION 3. The US Department of the Interior and US Environmental Protection Agency shall cooperate to  
18 create a council that meets 4 times yearly to evaluate and expand the program. This cooperative  
19 council is in charge of the implementation and enforcement of this bill. This cooperative council  
20 shall allot an amount not exceeding 100 billion dollars for the startup of the program, with a  
21 yearly renewed amount of 5 billion dollars for the continuance of the program.
- SECTION 4. This legislation will take effect on March 1st 2025.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## 102. A Bill to Repurpose the imported counterfeit medical devices destroyed by the Safeguarding Therapeutics Act

---

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

1 SECTION 1. This bill is assembled to repurpose imported counterfeit medical devices authorized for  
2 destruction by the Food and Drug Administration.

3 SECTION 2. The imported counterfeit medical devices collected by the Food and Drug Administration  
4 will be repurposed for educational and health care purposes. A counterfeit medical  
5 device may be mistaken for an authentic, licensed product. Counterfeit medical devices  
6 may include similar components to a licensed device or the wrong components.

7 1. The Food and Drug Administration will immediately desist in the destruction of  
8 imported counterfeit medical devices.

9 SECTION 3. United States Department of Health and Human Services will oversee  
10 enforcement along with the specific enforcement mechanism of repurposing the  
imported counterfeit medical devices.

A. Counterfeit medical devices be repurposed medical education.

B. Counterfeit medical devices be repurposed to supplement the rising cost of  
health care.

SECTION 4. This bill will begin to be enacted immediately after passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## **103. A Bill to include all GMO or Bioengineered content on food and drug labels.**

---

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 1 SECTION 1. The loopholes for non-declaration of GMO or Bioengineered food ingredients should be  
2 closed. All GMO or bioengineered food content should be declared on food labels.
- 3 SECTION 2. There are two loopholes for non-declaration of GMO or bioengineered food.
- 4 A. Highly processed foods that do not have the GMO or Bioengineered food  
5 detected after they are processed. Example: Canola oil.
- 6 B. Food that have meat or eggs as the main ingredient currently don't have to  
7 declare other ingredients that are GMO or bioengineered.
- 8 SECTION 3. The FDA should mandate that all GMO and bioengineered foods should be shown on all  
9 food and drug labels.
- 10 SECTION 4. This legislation will take effect immediately.
- 11 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## 104. A Bill to Limit Social Media for Children to Increase Internet Safety

---

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 1 SECTION 1. In order to address danger on the internet and to improve the safety of the internet,  
2 providers of social media may not allow children to access such social media platforms.
- 3 SECTION 2. Let the following definitions be used as interpretations:
- 4 A. Children are defined as being under the age of 16.
- 5 B. Social media platforms are defined as any virtual social networking site or online  
6 communities.
- 7 SECTION 3. The Federal Trade Commission will oversee enforcement along with the specific  
8 enforcement mechanism.
- 9 A. Individuals accessing social media platforms must provide valid identity  
10 documents, such as a passport, driver's license, or birth certificate, to verify age.
- 11 B. If a child is injured on a social media platform, the adult parent may bring a  
12 private right of civil action to obtain damages.
- 13 SECTION 4. This legislation will take effect immediately after passing.
- 14 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## 105. A Bill to Increase the Driving Age to 18 Years of Age

---

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

1 SECTION 1. The driving age will be increased to 18 years old, consistent throughout  
2 the nation.

3 SECTION 2. DOT refers to the Department of Transportation, a federal agency.  
4 DMV refers to the Department of Motor Vehicles, a state agency.

5 SECTION 3. The DOT will oversee the individual state DMVs for restructuring and  
6 compliance.

7 A. A system will be put into place for grandfathering individuals that  
8 reside in states that currently have a lower driving age.

9 B. New protocols would be created regarding learner's licenses,  
10 licenses to operate farming vehicles, and other unique circumstances.

11 SECTION 4. This legislation will take effect as soon as it is passed.

12 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## 106. A Bill to Expand the Space Program

---

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 1 SECTION 1. NASA will get humans to Mars by 2033.
- 2 SECTION 2. NASA refers to the National Aeronautics and Space Administration.
- 3 SECTION 3. NASA and the Department of the Interior will oversee enforcement.
  - 4 A. In the next 10 years, NASA will create an aggressive plan so the USA
  - 5 will be the first nation to land humans on Mars.
  - 6 B. NASA may contract with private companies to facilitate this mission.
  - 7 C. Funding for this legislation will come from the Department of the
  - 8 Interior.
- 9 SECTION 4. This legislation will take effect as soon as it is passed. All laws in conflict
- 10 SECTION 5. with this legislation are hereby declared null and void.

## 107. A Bill to Repeal Federal Income Tax

---

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 1 SECTION 1. This bill is designed to repeal the Federal Income Tax
- 2 SECTION 2. The Internal Revenue Service will immediately disband. The Internal  
3 Revenue Service will immediately call a halt to the collection and  
4 investigation of citizen taxation.
- 5 SECTION 3. United States Executive and Legislative Branches will oversee the  
6 disbanding of the Internal Revenue Service and all specific enforcement  
7 mechanisms.
- 8 A. The Legislative Branch will use The Government Accountability  
9 Office of the Congress to maintain oversight throughout the entire  
10 disbanding process.
- 11 B. The Executive Branch will use the President's Office of  
12 Management and Budget to maintain oversight throughout the entire  
13 disbanding process.
- 14 SECTION 4. This bill will begin to be enacted immediately after passage.
- 15 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
