

High School Judge Cheat Sheet

This sheet is designed to provide a basic guideline to the criteria that can be used for judging individual **SPEECH** events. Remember, feedback is crucial! Let them know of things they did well, but also what they could improve on. **To access your ballots go to live.speechwire.com** As soon as you are in your room, **press "Start Round"** in Speechwire.

<p>In a prep room (not your room), competitors are presented with a choice of three current event questions related to national and international current events. The competitor has 30 minutes to prepare a seven-minute speech answering the selected question. Judges will receive competitors one at a time, in 10-minute increments. Each student should stay to watch the remaining competitors.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> • Time: Up to 7 minutes (only valid if timed with stopwatch) • Time violations cannot place first (30 second grace period). • NO NOTES (Paper or Digital) • Those using notes should not rank first • Factually accurate • Organized, focused on topic, research referenced. • Judge opinion on the topic should not influence ranking. 	<p>Competitors write, memorize, and deliver a problem/solution speech with the intent to persuade the audience on a topic of significance. It usually has a problem, with causes, effects, and solutions. Competitors should remain in the room for the remaining competitors' speeches.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> • Time: up to 10 minutes (only valid if timed with stopwatch) • Time violations cannot place first (30 second grace period). • NO NOTES (Paper or Digital) • Those using notes should not rank first • Organized, flows, easy-to-follow. • Clear message • Relatable to any audience • Cited evidence to support the cause, problem, and a solution that could mitigate the problem. 	<p>Competitors memorize and deliver a portion or portions of a printed, published, & publicly delivered speech previously performed by someone else (commencement addresses, historical speeches, political speeches, celebrity speeches, etc.). There will be a brief introduction to the piece near the beginning of the speech.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> • Time: up to 10 minutes (only valid if timed with stopwatch) • Time violations cannot place first (30 second grace period). • NO NOTES (Paper or Digital) • Those using notes should not rank first • Entertaining, relatable, & flows • Speech choice appropriate for competition 	<p>Students have 7 minutes to prepare and give an improvised speech without notes.</p> <p><u>Draw:</u> (One speaker at a time) The judge has the speaker draw three prompts from an envelope. The speaker will choose one. The 7 minutes will start once the speaker chooses the topic (that topic is no longer valid for any other competitor). Competitors should remain in the room for all speeches.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> • Time: up to 7 minutes (only valid if timed with stopwatch) • 7 minutes includes preparation time and giving the speech. • Time violations cannot place first (30 second grace period). • NO NOTES (Paper or Digital) • Those using notes should not rank first in the round. • Organized, focused on topic, and supported using examples. 	<p>Competitors cut, memorize and perform their interpretation of a printed published, publicly accessible piece (script, movie, story, novel, etc.) including either single or multiple characters. PROPS ARE NOT PERMITTED (any item is considered a prop: chair, floor, table, etc.). In DUO, competitors may not make eye contact, nor touch. There will be a brief introduction to the piece near the beginning of the piece.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> • Time: up to 10 minutes • Time violations cannot place first (30 second grace period). • No scripts/notes • Time violations shouldn't rank first • DUO – Students do not touch or have eye contact except during the introduction. <p><u>Content/Delivery</u></p> <ul style="list-style-type: none"> • Entertaining • Piece should be challenging & appropriate for competition. • Not mimicking the original, but an interpreted message using original wording. • Characters clearly defined and differentiated. 	<p>Students deliver dramatic readings of published poems or pieces of published works.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> • Time: up to 10 minutes • Time violations should not place first (30 second grace period). • Maintains impression of reading from script in black binder • Students may not step away from performance spot <p><u>Content</u></p> <ul style="list-style-type: none"> • Entertaining • Piece choice challenging and appropriate for competition <p><u>Delivery</u></p> <ul style="list-style-type: none"> • Eye contact • Volume • Speaking rate • Confidence 	<p>A self-written speech on a topic of their choice, using logic and evidence to inform not advocate. Visual aids are allowed. All research should be cited verbally.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> • Time: up to 10 minutes • Time violations should not place first (30 second grace period). • Focused on topic • Organized and factual information with support of sources. • Should educate and entertain • Visual aids are engaging and have smooth delivery <p><u>Delivery</u></p> <ul style="list-style-type: none"> • Eye contact • Organized, knowledgeable, and informative • Confidence • Smooth delivery
<p>In ALL Speech Events:</p> <ul style="list-style-type: none"> • Please look for the following: eye contact, confidence, articulation, poise, tone, speed, body language) • Please make detailed comments on each ballot (positive & areas of improvement). • Rank students in first to last, no ties. Issue speaker points, 90 to 100 (highest points to 1st) <p><u>DISCLOSURE of RESULTS ANY round is PROHIBITED.</u></p>

<p>Contestants in Student Congress become legislators charged with the task of fulfilling the responsibilities of the US legislative branch of the federal government. There is a chamber of 15-18 competitors, as well as a PO (Presiding Officer-will run the room using Parliamentary Procedure)</p> <p><u>Regulations</u></p> <ul style="list-style-type: none"> • Student speeches are up to 3 minutes (PO will announce speech times) • Legislation authors have 2 minutes mandatory questioning period • All other questioning periods are 1 minute. • Students may not have visual aids • Speech should be on appropriate topic/side • Focused on topic, organized, factual accuracy, good composition, references • Eye Contact, confidence, appropriate/professional tone <p>Score every ballot – points range from 1 (poor) to 6 (excellent).</p> <p>Competitors should not receive extra points for questioning, however it should help determine ranking if the speech points are tied.</p> <p>Your opinion on the topic should not influence the ranking.</p> <p>Competitors rank 1 (best) -8 (look at how many speeches they made, how many points you gave for each speech, their decorum towards the chamber, participation, questioning, etc.)</p> <p>Please make detailed positive and constructive comments on each student ballot.</p>	<p>Team event that advocates or rejects a position posed by the resolution.
