A Bill to Dismantle "Big Tech" Companies

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. Big Tech companies shall be subject to divestiture by segmental
- 3 restructuring and to a 12% ownership cap.
- 4 **SECTION 2**. Definitions:
- 5 A. As used herein, "Big Tech companies" shall be defined as any corporation operating
- 6 within the technology sector with annual revenues exceeding \$25 billion.
- 7 B. "Segmental restructuring" shall be defined as the reorganization of a conglomerate
- 8 into distinct key business segments, each of which will become an independent
- 9 company.

10 C. The ownership cap shall be a 12% ownership limit on a single entity's holdings in

11 multiple tech companies.

12 **SECTION 3**. Enforcement:

13 A. The Federal Trade Commission shall be responsible for enforcing the provisions of 14 this bill.

15 B. The Commission shall exercise ongoing regulation over the market power of these 16 companies, and shall overview the restructuring plans of each conglomerate.

17 C. The Commission will also levy fines, commensurate with severity of violation, upon 18 companies that breach ownership regulations.

19 **SECTION 4**. The provisions of this bill shall take effect September 1, 2025.

20 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.

- Line 8: Section 2: A private plan for the purpose of this bill is a
- Line 9: plane that is being flown for a purpose other than
- Line 10: transportation of cargo, commercial transportation, and
- Line 11: science, farming, military, and medical uses.
- Line 12: Section 3: The Federal Aviation Administration and the
- Line 13: Environmental Protection Agency will oversee the
- Line 14: enforcement of this bill. The billing of this fee on a
- Line 15: monthly basis will be the enforcement mechanism of which
- Line 16: this bill is enforced.
- Line 17: Section 4: A Bill to Implement a Fee on Private Air Travel
- Line 18: will go into effect on July 1, 2024.
- Line 19: Section 5: Any and all laws that conflict with this policy
- Line 20: should be considered null and void.

A Bill to Cancel Student Loans after Seven Years

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. Student loan debt held or guaranteed by the United States shall be
- 3 canceled no more than seven years from the first day of repayment. All other student
- 4 loan debt shall be dischargeable in bankruptcy seven years from the first day of
- 5 repayment.
- 6 **SECTION 2**. Definitions:
- 7 A. As used herein, "student loan debt" shall include all loans made exclusively for the
- 8 purpose of paying postsecondary education expenses.
- 9 B. Cancellation of student loan debt shall be excluded from gross income.
- 10 **SECTION 3**. The Department of Education shall be responsible for enforcing the
- 11 provisions of this bill.
- 12 **SECTION 4**. The provisions of this bill shall take effect immediately upon passage.
- 13 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.

- 4 **Article 3**. United States representatives within NATO shall be responsible for
- 5 the enactment of this legislation.
- 6 **Article 4**. All laws in conflict with this legislation shall be declared null and void.

A Resolution to Replace the Gas Tax with a Mileage Tax

1 **WHEREAS**, Every day, more vehicles are put onto the road that do not require the use 2 of gasoline; and

- 3 **WHEREAS**, The Highway Trust Fund is highly dependent on the revenue of the
- 4 nationwide gas tax to maintain its function; and
- 5 **WHEREAS**, The Highway Trust Fund is the largest source of government funding to
- 6 improve road conditions; and
- 7 **WHEREAS**, The revenue from the gas tax will slowly deplete, leaving the Highway
- 8 Trust Fund unable to fulfill its duties; and
- 9 **WHEREAS**, A nationwide mileage tax based upon the number of miles driven would
- 10 be sustainable and also apply to every single car on the road; now, therefore be it
- 11 **RESOLVED**, That the Student Congress here assembled calls for the creation of a
- 12 nationwide mileage tax and the removal of the nationwide gas tax.

A Resolution to Protect the Right to Vote

- 1 **WHEREAS**, States routinely impose restrictions on the right to vote, from early
- 2 registration deadlines to ID requirements to limitations on absentee voting; and
- 3 WHEREAS, These restrictions have a disparate impact on persons of color, women,
- 4 young and elderly voters, persons with disabilities, and/or the poor; and
- 5 WHEREAS, The right to vote is too important to be subject to these restrictions; and
- 6 WHEREAS, The courts have found that such restrictions are, in most cases,
- 7 constitutional; and
- 8 WHEREAS, The Fourteenth Amendment provides a remedy by reducing the
- 9 congressional apportionment of states that prevent qualified voters from voting; and
- 10 WHEREAS, The Nineteenth and Twenty-Sixth Amendments permit the extension of
- 11 this remedy to protect women and voters between 18 and 20 years of age; and

12 **WHEREAS**, This provision of the Constitution has rarely been invoked but is needed 13 now more than ever; now, therefore, be it

- 14 **RESOLVED**, That the Student Congress here assembled calls for a proportional
- 15 reduction in the apportionment of states that impose any obstacles to voting, except on
- 16 the basis of felony conviction, as provided in Section 2 of the Fourteenth
- 17 Amendment.

A Bill to Abolish the International Criminal Court

Line 01 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

Line 02: **Article 1**: This bill will formally abolish the International Criminal Court. Any crimes Line 03: such as genocide, crimes against humanity/crimes of aggression, and war crimes Line 04: shall be tried by the United Nations instead.

Line 05: **Article 2**: Genocide is the killing of a group of people with the intention of destroying Line 06: that group, examples include Jewish people during World War II and the Tutsi in Line 07: Rwanda. Crimes against humanity are defined as deliberate acts made to harm or Line 08: kill other human beings on a large scale. War crimes are actions taken during war Line 09: that violate and do not follow the international rules set for war.

Line 10: Article 3: The United Nations will oversee the implementation of this bill.

Line 11: **Article 4**: This legislation will go into effect in the next election year for judges, Line 12: 2024.

Line 13: Article 5: All laws in conflict with this legislation are hereby declared null and void.

A Bill to Remove Members of Congress Who Backed the January 6 Insurrection

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1**. No person shall be a Representative or Senator who, having taken an

3 oath or affirmation to support and defend the Constitution of the United States,

4 subsequently incited, participated in, or gave material support to the insurrection,

5 rioting, unlawful entry, and related crimes committed at or near the United States

6 Capitol on January 6, 2021, or gave aid and comfort to any participant therein.

7 **SECTION 2**. The Congress finds that it has the authority to enact this legislation

8 pursuant to Sections 3 and 5 of the Fourteenth Amendment. The provisions of this bill 9 shall be interpreted broadly to include any conduct that a reasonable person would

10 find materially supportive of the insurrection.

11 **SECTION 3**. The Clerk of the House of Representatives and the Secretary of the

12 Senate shall be responsible for enforcing the provisions of this bill. Sitting members of 13

Congress subject to the provisions of this bill shall be deemed to have vacated their

14 seats, and their seats shall remain vacant until the next regular election. The

15 Congress, two-thirds of each house concurring therein, shall have the authority to

16 waive the provisions of this bill with respect to an individual member.

17 **SECTION 4**. The provisions of this bill shall take effect immediately upon passage.

18 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.
