A Resolution to End The Trade War With China

- 1 **WHEREAS,** The trade war with China has had devastating impacts on the United States

A Bill to Fund Hypersonic Weapon Development to Enhance the Military's Global Strike Capability

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States Department of Defence will be allocated \$30
2 billion per year until fiscal year 2053 to develop, construct and maintain
3 hypersonic weapons.

4 **SECTION 2.** “Hypersonic Weapons” are defined as weapons that can travel at speeds of at
5 least 5 times the speed of sound. These weapons are highly maneuverable and
6 can change course during flight. The 2 main categories of Hypersonic
7 Weapons are hypersonic glide vehicles and hypersonic cruise missiles.

8 **SECTION 3.** The Department of Defence will be responsible for the implementation of
9 this bill.

10 A. The Department of Defence budget will be increased by \$30 billion
11 per year until fiscal year 2053 to facilitate the funding of this bill.

12 **SECTION 4.** This legislation will take effect in FY 2025.

13 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.



A Bill to Abolish Daylight Savings Time to Eliminate General Risk of Sleep Cycle Disruption

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States government hereby abolishes daylight saving time,
2 establishing a consistent year-round standard time to enhance public
3 well-being, streamline schedules, and mitigate the disruptive effects on
4 sleep patterns and daily routines.

5 **SECTION 2.** This bill voids DST (Daylight Savings Time)

6 **SECTION 3.** The DOT (Department of Transportation) will oversee the enforcement of
7 this bill.

8 **SECTION 4.** This legislation will take effect on [May 1st, 2024]. All laws in conflict with
9 this legislation are hereby declared null and void.

The Flat Tax Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1. **Section 1:** This legislation will hereby abolish the United States current system
2. for taxation under the tax bracket and will be replaced by a
3. standardized flat tax rate of 17%. This does not include the removal
4. of standardized deductions.
5. **Section 2:** As well as the introduction of the flat tax, all those who make an
6. annual household income of 11,000 or less USD for single and
7. Married filing separately, 22,000 or less USD for married filing
8. together, and 15,750 or less USD for the head of households will
9. be subjected to no taxation from the US government.
10. **Section 3:** The Internal Revenue Service will be responsible for the
11. implementation of this legislation.
12. **Section 4:** This legislation will take effect after the 2024 tax cycle on May 1,
13. 2024. All laws in conflict with this legislation are hereby declared null
14. and void.

A Bill to Restrict Military Aid to Israel to Promote Human Rights

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Over the course of the last month, over 10,000 civilians in Gaza have been
2 killed as a result of the conflict between Hamas and the Israeli Defense
3 Forces (IDF). This bill aims to restrict military aid to Israel in order to
4 incentivise a ceasefire between Israel and Hamas; thus preventing any
5 further civilian casualties as a result of the conflict.

6 **SECTION 2.** Military aid as defined by this bill includes, weapons, support equipment,
7 and monetary assets used by the IDF for martial actions.

8 A ceasefire is defined as a complete halt in the fighting, requiring both
9 Israel and Hamas to cease military actions against each other.

10 **SECTION 3.** The US Department of State's Office of Foreign Assistance will oversee the
11 enforcement of this bill.

12 A. Civilian and humanitarian aid will still be permitted under this
13 legislation.

14 B. The Office of Foreign Assistance will oversee the funding we continue
15 to send, ensuring it is used for its stated purposes.

16 C. American advisors from the Department of Defense and Department of
17 State will be sent to both observe and record military actions as part of
18 the conflict, and ensure no humanitarian funding is misused.

19 **SECTION 4.** This legislation will take effect upon passing. All laws in conflict with this
20 legislation are hereby declared null and void.

A Bill to Decriminalize Prostitution and Provide Rehabilitation to Sex Workers

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** This congress acknowledges the dangers related to prostitution leading to
2 detrimental harms and a difficulty to remove oneself from the industry. As
3 such, this bill will officially decriminalize prostitution and reintegrate sex
4 workers into a legal society without oppressive punishments inhibiting their
5 future. Furthermore this bill will provide support to sex workers through
6 rehabilitation seeking to improve circumstances.

7 **SECTION 2.** Rehabilitation is defined as the idea that the purpose of punishment is to
8 provide treatment and training to an individual so that they are made
9 capable of returning to society and functioning as a law-abiding member of
10 the community. Decriminalization is defined as not legalization but that the
11 legal system would not prosecute any individual for the action. Prostitution
12 is defined as the illegal practice or occupation of engaging in sexual activity
13 with someone for payment. Sex workers are defined as a person whose
14 work involves committing illegal forms of sexual activity.

15 A. This bill would not include instances of sex trafficking, defined as
16 human trafficking for the purpose of sexual exploitation. Sexual acts
17 in which the victims are forced into sexual acts nonconsensually are
18 also not included under this bill.

19 **SECTION 3.** The Department of Justice, the Department of Health, the Human Services
20 and the Department of Corrections will be in charge of overseeing the
21 implementation of this bill.

22 A. Should any issues arise from the implementation of this bill the proper
23 corrections will be overseen by the FBI and Department of Justice.

24 B. Any monetary support that may need to be implemented for this bill will
25 be taken from the Department of Defense.

26 **SECTION 4.** This legislation will take effect on FY 2025. All laws in conflict with this
27 legislation are hereby declared null and void.
