# A Bill to Revitalize Commercial Supersonic Flight

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** FAR Section 91.817, the 1973 ban on commercial supersonic flight over U.S.  
3 territory, is hereby repealed. Commercial supersonic service may now  
4 operate under the same policies and regulations that govern other  
5 commercial air traffic.

6 **SECTION 2.** The Federal Aviation Administration (FAA) shall oversee this legislation.

7 **SECTION 3.** This legislation shall take effect on January 1, 2024.

8 **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Institute a Vegan Diet in Primary and Secondary Schools

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Any primary or secondary schools that receive any amount of federal funding  
3 are hereby required to adhere to the principles of veganism in the foods and  
4 beverages they serve to students. That is, they may no longer serve any  
5 foods or beverages that were sourced from animals, namely meat, dairy, and  
6 eggs. Non-federally funded schools are encouraged to follow suit as well.

7 **SECTION 2.** Any school or district that is found out of compliance with this legislation  
8 shall lose 50% of its federal funding until such time as compliance is reached.

9 **SECTION 3.** This legislation shall be jointly overseen by the National School Lunch  
10 Program and the Department of Education

11 **SECTION 4.** This legislation shall take effect on July 1, 2025. All laws in conflict with this  
12 legislation are hereby declared null and void.

# A Bill to End Single-Stream Recycling

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Municipalities throughout the United States and its territories are directed to  
3 abandon all single-stream recycling initiatives.

4 **SECTION 2.** Households and businesses are encouraged to continue recycling, and  
5 municipalities are directed to undertake initiatives that will make sorted  
6 recycling as efficient and user-friendly as practicable. Congress shall direct an  
7 additional \$5 billion annually to the Environmental Protection Agency (EPA)  
8 to support such initiatives.

9 **SECTION 3.** This legislation shall be overseen by the EPA.

10 **SECTION 4.** This legislation shall take effect on January 1, 2026. All laws in conflict with  
11 this legislation are hereby declared null and void.

# A Bill to Allow for Consumption of Horse Meat

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All bans in place against the slaughter, sale, and consumption of horse meat  
3 within the United States are hereby lifted, as are bans preventing the use of  
4 federal funds for mandatory inspections of horse meat slaughterhouses.

5 **SECTION 2.** Congress shall transfer \$5 billion in annual beef subsidies to the horse meat  
6 industry to promote the consumption of horse meat as an alternative to  
7 other meat products.

8 **SECTION 3.** The Food and Drug Administration (FDA) shall oversee this legislation.

9 **SECTION 4.** This legislation shall take effect on January 1, 2026. All laws in conflict with  
10 this legislation are hereby declared null and void.

## A Bill to End Drug Induced Homicide Laws

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All Drug Induced Homicide laws shall be repealed and all pending related  
3 criminal charges dropped.

4 **SECTION 2.** "Drug Induced Homicide Law" is defined as any law that holds drug  
5 distributors criminally responsible for overdose deaths or otherwise holds  
6 drug distributors liable for the abuse of drugs.

7 **SECTION 3.** The Department of Justice will oversee the implementation of this  
8 legislation.

9 **SECTION 4.** This legislation will take effect immediately upon passage. All laws in conflict  
10 with this legislation are hereby declared null and void.

# The Three Sisters Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Current farming practices contribute to climate change and the water crisis,  
3 leading the agricultural industry to use more than half of Earth’s water and  
4 negatively contribute to greenhouse gases, resulting in the deaths of 4.7  
5 million people per year.

6 **SECTION 2.** In order to support American farmers adopting Indigenous farming methods  
7 such as the Three sisters:

8 A. \$10 billion shall be allocated to the USDA and EPA in order to research  
9 and develop new sustainable solutions to current agricultural farming  
10 practices.

11 B. \$20 billion shall be given to Native American tribes as reparations for the  
12 genocide of their people caused by Congress.

13 **SECTION 4.** This legislation will take effect on January 1, 2025. All laws in conflict with  
14 this legislation are hereby declared null and void.

# A Bill to Ban the Use of LLMs for Federal Prosecutors

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** LLMs are hereby prohibited for use by federal prosecutors in legal  
3 proceedings.

4 **SECTION 2.** "LLM" stands for "Large Language Model," which is defined as any chatbot  
5 technology that can process natural language and autonomously generate a  
6 response in human-like text.

7 **SECTION 3.** This legislation will be overseen by the Department of Justice.

8 **SECTION 4.** This legislation will take effect immediately after passage. All laws in conflict  
9 with this legislation are hereby declared null and void.

# A Bill to Dismantle International Border Fortifications

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All walls and other fortifications existing along the United States'  
3 international land borders between ports of entry are to be dismantled  
4 within three years of the passage of this legislation. Any existing plans to  
5 expand this system of fortifications and walls shall be abandoned  
6 immediately.

7 **SECTION 2.** This legislation shall be overseen by the Department of Homeland Security,  
8 which is encourage to contract out the demolition and removal in such a way  
9 that best mitigates unemployment and underemployment in the affected  
10 areas.

11 **SECTION 3.** This legislation shall take effect immediately upon passage. All laws in  
12 conflict with this legislation are hereby declared null and void.

## A Resolution to Call for the Recognition of Somaliland

1 **WHEREAS** The Republic of Somaliland’s de facto government is one of the most  
2 effectively functioning in the Horn of Africa, and Somaliland is thriving  
3 despite the political limbo in which they find themselves; and

4 **WHEREAS** The Federal Republic of Somalia, which has de jure control over Somaliland,  
5 is conversely one of the globe’s most failed states and can provide little value  
6 to Somaliland and its people; and

7 **WHEREAS** Somaliland and its people have a right to the additional opportunities that  
8 would accompany official recognition, and for the United States not to  
9 support them in achieving those rights amounts to a gross abandonment of  
10 this nation’s alleged values; now therefore be it

11 **RESOLVED** by the Congress here assembled that the Executive Branch is called upon to  
12 recognize Somaliland immediately and to establish full diplomatic relations  
13 with the Republic; and be it

14 **FURTHER RESOLVED** that Congress strongly encourages the United Nations, other global  
15 organizations, and nations around the world to do the same; and be it

16 **FURTHER RESOLVED** that Congress conveys its eternal support for Somaliland and its  
17 people and undertakes to consider further legislation to help Somaliland  
18 defend itself as it comes into its own as a full nation, should such legislation  
19 become advisable.
