## A Bill to Increase Naval and Military Operations in the Black Sea to Deter Russian Expansion

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:				
2	SECTION 1.	The United States Department of the Navy and The Department of			
3		Defense (DOD) shall increase naval and military operations, surveillance,			
4		and intelligence gathering in the Black Sea.			
5	A.	The increase in Black Sea operations will come from transferring 50% of			
6		the current US naval fleet in the Persian Gulf to the Black Sea.			
7	SECTION 2.	A "US naval fleet" shall be defined as any US military equipment, naval			
8		equipment, ships, aircraft, or military presence currently deployed in the			
9		Persian Gulf.			
10	SECTION 3.	The Department of Defense will oversee the implementation of this			
11		legislation.			
12	SECTION 4.	This legislation will take effect immediately upon passage. All laws in			
13		conflict with this legislation are hereby declared null and void.

1	SECTION 1.	A committee will be created within the Food and Drug	
2	Administratio	n (FDA) to regulate Direct-to-Consumer (DTC) advertising in	
3	the United Sta	ates. Advertisements regarding pharmaceutical products	
4	being played o	on any form of media will be reviewed before publication to	
5	ensure the credibility of the descriptions included within the		
6	advertisement.		
7	SECTION 2.	Direct-to-consumer advertising is defined as a marketing	
8	promotion aimed toward the patient instead of healthcare professionals.		
9	The media be	ing regulated includes print, social media, TV, radio, and	
10	other forms of advertisement.		
11	SECTION 3.	This legislation will be enforced by the Food and Drug	
12	Administratio	n.	
13	A. \$1 billion i	n funding will be granted to create this committee and	
14	provide it	with the necessary staff and resources to regulate DTC	
15	advertising properly.		
16	SECTION 4.	This legislation will be implemented on January 1st, 2025.	
17	SECTION 5.	All laws in conflict with this legislation are hereby declared	
18	null and void.
