3	Article I:	\$50 million shall be allocated to combat labor union busting. This money	
4		shall be allocated to the Department of Labor to create a committee	
5		charged with investigating corporations using unjust and underhanded	
6		methods to break up and/or weaken unions.	
7	Article II:	A labor union is a group of two or more employees who join together to	
8		advance common interests such as wages, benefits, schedules and other	
9		employment terms and conditions. Union busting is a range of activities	
10		undertaken to disrupt or prevent the formation of trade unions or their	
11		attempts to grow their membership in a workplace.	
12	Article III:	This bill shall go into effect July 1, 2024	
13	Article IV:	The Department of Labor shall be tasked with enforcing this bill	
14		a) The Department of Labor shall create a committee that will be	
15		tasked with investigating cases of illegal union busting.	
16		b) US employees shall be allocated a place to report employers	
17		who are union busting.

A Bill to Implement Carbon Pricing

Be it enacted by this Palm Beach Catholic Forensic League Student Congress here
assembled that:

3	Article I:	A carbon tax will be implemented in the United States on all for-profit
4		companies that emit more than 30 metric tons of carbon dioxide a year,
5		starting at \$10 per metric ton in the first year and rising by \$10
6		in each following year until it reaches \$60 per metric ton. Additionally,
7		all federal subsidies allocated to fossil fuel corporations shall cease
8		upon passage.
9	Article II:	Carbon tax will be defined as a tax on the emission of carbon dioxide
10		by for-profit companies that conduct onshore and/or offshore activities.
11		Subsidies for oil and natural gas companies will be defined as any
12		financial aid given by Congress to these companies.
13	Article III	The Department of Energy and the Internal Revenue Service will
14		oversee the oversight & implementation of this legislation.
15	Article IV:	This legislation will take effect at the beginning of 2025.
16	Article V:	All laws and portions of laws in conflict with this legislation are hereby
17		declared null and void.

A Bill to Enhance Aid in The Northern Triangle

1	Be it enacted by the Congress here assembled that:	
2	SECTION 1.	An additional, cumulative \$50 billion shall be allocated to aid and foreign
3		direct investment in the Northern Triangle to bolster economic and social
4		opportunity.
5		A) At least 50% of the aid will be used to expand the Central America
6		Regional Security Initiative (CARSI) and its humanitarian efforts.
7		B) The remaining funds (after the allocation detailed in section 1 A) shall
8		be allocated to foreign direct investment.
9	SECTION 2.	Humanitarian efforts shall be defined as (but not limited to) the development of
10		economic and social opportunity in the Northern Triangle (e.g., the creation and
11		investment in hospitals, schools, and small businesses) with the ultimate goal of
12		alleviating poverty and decreasing violence. Foreign direct investment shall be
13		defined as aid carried out utilizing local non-governmental organizations
14		(NGOs) in the region that have been approved by the Department of State
15		(DOS). Aid shall be allocated via the discretion of the implementing body with
16		the oversight of the DOS.
17	SECTION 3.	The Department of State (DOS) shall be tasked with the implementation of this
18		legislation. The DOS will do an evaluation and audit regarding the efficacy of
19		aid in poverty reduction and violence reduction. Funding allocation will come
20		out of the Department of Defense budget.
21	SECTION 4.	This legislation will take effect at the beginning of the next fiscal year. All laws
22		in conflict with this legislation are hereby declared null and void.
