# A Bill to Raise the Youth Minimum Wage to the Federal Minimum Wage

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	In the first 90 calendar days of an employee under 20 doing a job, the
2		employer may pay a lower wage for a limited period. This wage cannot be
3		below \$4.25 an hour. This bill will raise this to the federal minimum wage,
4		or \$7.25 an hour. Employers will not be able to pay employees below 20
5		under the federal minimum wage in the first 90 calendar days of
6		employment.
7	SECTION 2.	Youth Minimum Wage shall be defined as the minimum wage that
8		employers can pay employees below the age of 20 for the first 90 calendar
9		days of employment, which is \$4.25 an hour. The Federal Minimum Wage
10		shall be defined as the minimum wage of \$7.25 an hour.
11	SECTION 3.	The US Department of Labor will oversee enforcement.
12		A. For non-willful violations, the penalty shall be double the wages owed
13		to the employee from the start of employment.
14		B. For willful violations, the penalty shall be three times the wages owed
15		to the employee from the start of employment.
16	SECTION 4.	This legislation will take effect in the next fiscal year. All laws in conflict with
17		this legislation are hereby declared null and void.

### A Bill to Eliminate Crypto

- 1. Section 1. Cryptocurrencies and crypto-mining will no longer be legal within the United 2. States. All crypto currently owned and distributed by American citizens and 3. residents should be exchanged for fiat currency. 4. Section 2. Cryptocurrencies are defined as any digital currency that exists within the 5. blockchain or a digital currency designed to work as a medium of exchange 6. through a computer network that is not reliant on any central authority, such 7. as a government or bank, to uphold or maintain it. Crypto-mining is defined 8. as the process of creating new coins and validating cryptocurrency 9. transactions on a blockchain network and adding them to a distributed ledger. 10. Section 3. These changes will be enforced by the U.S. Department of the Treasury. The 11. currency exchange will occur at a fixed rate determined by the treasury. Any 12. entity found in violation of this mandate will be fined \$100. 13. Section 4. This bill will be imposed in December 31, 2025. All crypto conversions should 14. be complete by 2027.
- 15. **Section 5.** All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Save Social Security

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The United States shall remove the Social Security Tax Cap.
- 3 **SECTION 2**. The Social Security Cap is defined as the cap on income subject to
- 4 taxation by Social Security taxes.
- 5 **SECTION 3.** The United States Social Security Administration and Internal Revenue
- Service shall be charged with implementation and enforcement of this
- 7 law.
- 8 **SECTION 4.** This legislation will take effect on Jan 1, 2025. All laws in conflict with this
- 9 legislation are hereby declared null and void.

# A Resolution to Repeal The Federal Uniform Drinking Age Act of 1984

1	WHEREAS,	Driving Under the Influence is not strictly an under 21 issue; and
2	WHEREAS,	People under the age of 21 consume alcohol; and
3	WHEREAS,	Driving Under the Influence enforcement is not a crime only enforced on
4		federal highways; and
5	WHEREAS,	The federal government only pays for ~25% of highways; and
6	WHEREAS,	state and local governments pay the remainder; and
7	WHEREAS,	states are already allowed to set different mandates for private property
8		alcohol consumption; and
9	WHEREAS,	the minimum legal drinking age (MLDA) would not lead to an increase in
10		total traffic fatalities as a drunk driving percentage; and
11	WHEREAS,	the MLDA being lowered would result in an egregious 10% federal cut in
12		Federal Highway spending for any State wishing to lower it; now, therefore,
13		be it
14	RESOLVED,	By the Congress here assembled that The Federal Uniform Drinking Age Act
15		of 1984 shall be repealed.

## A Bill To Replace All Asphalt Roads With Concrete As They Wear Out

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	All asphalt roads will be replaced with concrete when they are no
2		longer suitable to drive on.
3	SECTION 2	Road: A long paved surface used for traveling from place to
4		place.
5		Asphalt: A mixture of dark bituminous pitch with sand or gravel,
6		used for surfacing roads, flooring, roofing, etc.
7		Concrete: a heavy, rough building material made from a mixture
8		of broken stone or gravel, sand, cement, and water, that can be
9		spread or poured into molds and that forms a mass resembling
10		stone on hardening.
11		Wear Out: To use until the thing is no longer safe and needs
12		replacement.
13	SECTION 3.	State Governments and the National Highway Administration will
14		oversee enforcement.
15		A. The State Governments and the National Highway
16		Administration will use funds that would usually be used for
17		asphalt to buy the concrete necessary for the
18		implementation of this bill.
19	SECTION 4.	This legislation will take effect on January 1, 2025. All laws in
20		conflict with this legislation are hereby declared null and void.
