

## A Bill to Reduce Drug Recidivism

1. **Section 1.** The United States will decriminalize all illicit drugs. Instead of criminal penalty
2. anyone found in possession of or under the influence of illicit drugs will enter
3. a court-mandated rehabilitation program. Those currently imprisoned for drug
4. related crimes will also be entered into a program upon implementation of
5. this bill.
6. **Section 2.** Illicit drugs is defined as drugs that are illegal to make, sell, or use for non-
7. medical purposes. Rehabilitation programs are programs designed to reduce
8. recidivism among anyone convicted of a drug related offense by improving
9. their behaviors, skills, mental health, social functioning, and access to
10. education and employment.
11. **Section 3.** These changes will be enforced by the The Substance Abuse and Mental
12. Health Services Administration and the United States Drug Enforcement
13. Administration. Violations of this act may be turned over to the various states'
14. Attorneys General for criminal and civil penalties as proscribed by the laws of
15. that state.
16. **Section 4.** This bill will be imposed on January 1, 2025. All individuals currently
17. imprisoned for drug related crimes must be placed in rehabilitation programs
18. By July 1, 2025.
19. **Section 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A Bill to Discontinue the Communist Control Act of 1954**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The Communist Control Act of 1954 will hereby be abolished.

3 **SECTION 2.** The Communist Control Act of 1954, or otherwise formally known as Public Law  
4 83-637, is defined as the act passed by the 83rd Congress, that overall outlaws the Communist  
5 Party of the United States, outlaws membership to or in support of the Communist Party of the  
6 United States or any other “Communist-action” organizations; this act also prohibits members in  
7 these communist organizations from serving in certain representative capacities, including and  
8 not limited to, in labor unions or office. The members of the Communist Party are also subject to  
9 the penalties and provisions of the Internal Security Act of 1950.

10 **SECTION 3.** The United States Department of State as a whole will oversee the dissolution of  
11 the logistics, enforcements, mandates, or references in official documents or procedures, of the  
12 Communist Control Act.

13 **SECTION 4.** This legislation will take effect on January 1st, 2025. All laws in conflict with this  
14 legislation are hereby declared null and void.

## **A Bill to Fight Binge Drinking and Drug Abuse**

1. **Section 1.** All US high schools and universities must include education on binge
2. drinking and fentanyl abuse to all students.
3. **Section 2.** Binge Drinking will be defined as consuming large quantities of alcohol in a
4. single setting. Fentanyl use will be defined as abusing the drug fentanyl for
5. uses besides those prescribed by a licensed physician.
6. **Section 3.** These changes will be enforced by the Department of Health and Human
7. Services and the Substance Abuse and Mental Health Services
8. Administration. Any school or university found in violation of this mandate
9. Will be fined \$1000 per student for every year they fail to implement the
10. course.
11. **Section 4.** This bill will be imposed in January 1, 2026 in order to allow states time to
12. reallocate necessary funding.
13. **Section 5.** All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Restore Sanity to American Schools

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States shall ban the weighting of course grades for calculation  
3 in Grade Point Averages in public K-12 education. No public school shall  
4 produce nor advertise a grade point average outside of the mathematical  
5 bound of 0.0 to 4.0.

6 **SECTION 2.** "Weighting of grades" shall be defined as assigning any point value higher  
7 than 4.0 to the grade of any course. Grade Point Average shall be defined  
8 as the mathematical mean of the points assigned to the grade of each  
9 course in a given school career. Public school shall be defined as any  
10 school majority funded by state, local, and federal tax revenue.

11 **SECTION 3.** The United States Department of Education shall be charged with  
12 enforcement of this law.

13 A. Any public school in violation will fined \$100 per student per school  
14 year.

15 **SECTION 4.** This legislation will take effect on July 1, 2025. All laws in conflict with this  
16 legislation are hereby declared null and void.

# A Bill to Raise CAFE to Reduce US Dependence on Foreign Oil

1. **Section 1.** CAFE standards will be raised by 1MPG on newly manufactured vehicles
2. every year until 2050.
3. **Section 2.** Newly manufactured vehicles is defined as a vehicle recently assembled and
4. never titled.
5. **Section 3.** These changes will be enforced by the National Highway Traffic Safety
6. Administration. Any organization found in violation of this mandate will
7. Be fined \$10,000 per new vehicle sold
8. **Section 4.** This bill will be effective January 1, 2025.
9. **Section 5.** All laws in conflict with this legislation are hereby declared null and void.
