A Bill to Improve Saudi Humane Intervention Endeavors and Logistics Domestically (S.H.I.E.L.D. ACT)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1. **SECTION 1.** The United States shall hereby formally initiate negotiations for the
2. formation of a defense pact with Saudi Arabia, whereas the specificities
3. of the pact itself shall be set through the aforementioned future
4. negotiation.
5. **SECTION 2.** A. A defense pact shall be defined as a mutually agreed-upon set of
6. conditions pertaining to the reciprocal military defense of both
7. involved nations.
8. B. It shall be clearly established in any and all negotiations that the
9. premise of nuclear mutually assured destruction will not be a
10. factor in any possible defense pact.
11. C. In order to initiate the negotiation procedure, the Saudi Arabian
12. Ministry of Defense must first acknowledge and accept that the
13. The United States reserves the right to withdraw from the
14. negotiation of the defense pact at any time without retaliation, or
15. else risk political and economic isolation.
16. **SECTION 3.** The US Department of State in conjunction with the US Ambassador to
17. Saudi Arabia shall be responsible for the implementation and oversight of
18. this bill.
19. **SECTION 4.** This legislation shall be implemented immediately upon passage.
20. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and
21. void.

Introduced for Congressional Debate by Western High School

A Bill to Aid Myanmar

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The United States shall hereby donate and deliver \$200 million in
2 humanitarian aid to the citizens of Myanmar through Myanmar's
3 maritime border with Indonesia. US troops will be allotted as necessary to
4 deliver the aid to USAID representatives at the border.
- 5 **SECTION 2.** Humanitarian aid shall consist of a combination of agricultural
6 supplication, temporary housing, bottled water, and medical supplies,
7 including but not limited to; vaccines and first aid equipment.
- 8 **SECTION 3.** The US Department of State in conjunction with USAID will be
9 responsible for the implementation and oversight of this bill.
- 10 **SECTION 4.** This legislation shall be implemented immediately upon passage.
- 11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and
12 void.

Introduced for Congressional Debate by Western High School

A Bill To Better The Counseling And Resources for Emotional Development (C.A.R.E.D)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1. **SECTION 1.** This congress will provide \$10 billion to subsidize the employment
2. of mental health experts for schools, as well as to provide debt
3. forgiveness programs for mental health experts in exchange for
4. employment in schools, for a minimum of 10 years. And introduce
5. a ratio of a maximum of 100/1 students to mental health experts
6. in publicly funded schools
7. **SECTION 2.** The following shall be defined as:
8. **A.** Mental health expert shall be defined as individual with licencing
9. necessary for a position of a child psychologist
10. **B.** Debt forgiveness shall be defined as a grant afforded by the DOEd
11. to debt holders to a minimum of 70%
12. **B2.** DOEd shall be directed to target areas of low income
13. **SECTION 3.** The Department of Education shall be responsible for implementation
15. and oversight of grants, identifying low income areas, and implementing
16. fair contracts of employment after hiring.
17. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and
18. void.

Introduced for Congressional Debate by Western High School

A Resolution to Encourage Shark Farming

1. **Whereas**, Currently, 167 different species of sharks are threatened with extinction.
2. Humans have killed over 80 million sharks for food, medicine, and leather. 25 million of
3. these sharks are members of threatened species; and
4. **Whereas**, Shark is a very common ingredient for food throughout the world in countries
5. such as Iceland, Japan, Australia, Asia, India, Africa, Mexico, and Yemen. Due to shark
6. being an important ingredient in many cultures, it is crucial to find methods of obtaining
7. sharks without it affecting the marine ecosystem; and
8. **Whereas**, Shark has become a crucial ingredient for many medications treating various
9. ailments.
10. **Therefore**, This congress shall encourage the establishment and sustainable
11. development of shark farms both domestically and internationally.

Introduced for Congressional Debate by West Boca Raton High School.

A Bill to Address the Climate Crisis

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States Congress will provide funding and technical assistance for communities to prepare for and adapt to the impacts of climate change, such as sea level rise, increased frequency of natural disasters, and changing precipitation patterns.

SECTION 2. Furthermore, the United States will provide funding for international climate cooperation and participation in international climate agreements, such as the Paris Agreement.

SECTION 3. The United States will promote energy efficiency through tax credits, rebates, and building codes that require more efficient use of energy. The United States government will provide incentives for the deployment of renewable energy sources, such as solar, wind, and hydropower, as well as energy storage and transmission technologies.

A. The United States government will provide tax cuts for corporations that go solar and/or use renewable energy sources (15%-25% max).

B. The tax cut will be decided after an inspection by the EPA. It will be based on how hard the company is trying to protect the climate.

SECTION 4. This legislation will be overseen by the Environmental Protection Agency (EPA) and the Internal Revenue Service (IRS).

SECTION 5. This legislation will take effect on FY 2025. All laws in conflict with this legislation are hereby declared null and void.

The Compulsory Voting Act of 2023

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All eligible voters must be registered to vote and participate in all federal and state elections unless they have a valid excuse.

SECTION 2. Eligible citizens are defined as those over 18 years of age, an official US citizen and meet their state residency and other requirements. A valid excuse is defined as those who have an illness or disability that prevents an individual from physically or mentally participating to vote.

SECTION 3. The Election Assistance Commission will be responsible for enforcing the provisions of this bill.

A. The Commission shall work with state election authorities to ensure compliance with the compulsory voting requirement and to address any issues that arise during the implementation of the bill.

B. Penalties for noncompliance with the compulsory voting requirement, will include fines up to \$50 or community service.

SECTION 4. This legislation will take effect on November 5th, 2024. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Open American Immigration

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States of America hereby adopts an open-door policy to all non-violent immigrants.

SECTION 2. Open door policy is defined as a no-limit policy on people seeking access to live and work in the United States. Non-violent immigrants are any persons seeking to immigrate to the U.S. without intentions of criminal activity.

SECTION 3. The Department of Homeland Security in coordination with the U.S. Citizenship and Immigration Services and the U.S. Immigration and Customs Enforcement will be responsible for the enforcement of this bill.

A. All current persons living in the U.S. without documentation are required to obtain formal documentation to continue live in the U.S.

SECTION 4. This legislation will take effect immediately. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Lower Prescription Drug Costs

SECTION 1: The United States will enact a markup cap for all prescription drugs.

- a) The United States will cap markup prices by companies at 7% for prescription drugs.
- b) Companies that refuse to follow the legislation will have a federal tax on profits double than the percentage of markup costs.

SECTION 2: The following definitions apply:

- a) Prescriptions drugs will be defined as any drug that is obtained with a prescription.
- b) Markup caps will be defined as a method to prevent companies from marking up manufactured products to gain more profit.

SECTION 3: The Food and Drug Administration along with the Internal Revenue Service will be responsible for the implementation of this bill.

SECTION 4: This legislation will take effect at the start of FY 2026.

SECTION 5: All laws in conflict with this legislation are hereby declared null and void.

A Bill to prohibit children under 15 to access to social media

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. This bill will prohibit children under the age of 15 from accessing all social media platforms.

SECTION 2. Social media are websites applications that enable users to create and share content or to participate in social networking.

SECTION 3. The Federal Communications Commission shall enforce this law. The Federal Communications Commission regulates interstate and international communications by radio, television, wire, satellite and cable in all 50 states, the District of Columbia and U.S. territories. The Federal Communications Commission will contact social media platforms included but are not limited to: Facebook, Twitter, TikTok, Snapchat, Reddit, Instagram, and other social media sites that promote communication with others digitally to comply with the new law.

SECTION 4. This legislation will take effect on August 21, 2024-25 school year. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Repeal the PATRIOT Act to Ensure the Rights and Privacy of Americans

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The Uniting and Strengthening America by Providing Appropriate Tools Required to Intercept and Obstruct Terrorism (USA PATRIOT) Act of 2001 will be repealed and considered null and void.

SECTION 2. Repeal means to revoke or annul all aspects of the law.

SECTION 3. The Department of Justice will oversee enforcement of this law.

SECTION 4. This legislation will take effect on January 1, 2024. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Enhance Digital Privacy and Data Protection

WHEREAS, The current state of digital privacy and data protection poses significant concerns regarding the collection, use, and potential misuse of personal data;

WHEREAS, The scope of the issue extends to the pervasive and often unchecked collection of personal data by various entities in the digital realm, raising a pressing need for comprehensive safeguards and standards;

WHEREAS, The impact of inadequate digital privacy measures has resulted in breaches of personal data leading to identity theft, unauthorized access, and potential manipulation of individuals' personal information;

NOW, THEREFORE, be it

RESOLVED, This bill will be overseen by the Federal Digital Privacy and Data Protection Commission. This federal agency deals with programs supporting data and digital privacy.

FURTHER RESOLVED, That the Congress recommends the establishment of the Federal Digital Privacy and Data Protection Commission to support the act of digital privacy and data protection for US citizens, which will be safeguarding individuals' digital rights.

A Bill to Establish Universal Preschool

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States Department of Education will integrate universal preschool into our public school system.

SECTION 2. Universal Preschool is a publicly funded and tuition-free program for age-eligible children. Age-eligible children are children who are between the ages of 2-5.

SECTION 3. The United States Department of Education will oversee and enforce this legislation.

A. The DOE shall have a budget of \$40 billion per annum.

B. Subsidies shall be given to the early childhood providers within the \$40 billion budget.

SECTION 4. This legislation will take effect on July 1, 2025. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Suspend Turkey's Veto Power in NATO

1 **WHEREAS,** Turkey threatens to exploit their veto power ; and
2 **WHEREAS,** It is hindering NATO's ethics and effectivity; and
3 **WHEREAS,** There's been numerous examples of Turkey blocking NATO
4 actions for leverage; and
5 **WHEREAS,** They haven't been held accountable for several abuses
6 against the Kurdish people and being an untrustworthy ally; now,
7 therefore, be it
8 **RESOLVED,** That the Congress here assembled recommends the
9 suspension of Turkey's VETO power.

The CLOSE AI Act

(Creating Liability for Optimal SEcurity in AI)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Under this law any computer service generated by Artificial Intelligence
2 will not receive immunity under Section 230 of the Communications
3 Decency Act of 1996 for any civil claims or criminal charges. As AI rapidly
4 develops with little oversight, the United States faces unprecedented
5 threats from AI generated misinformation or false information such as
6 deepfakes.

7 **SECTION 2.** Artificial Intelligence (AI) will be defined as the following: an artificial
8 intelligence system that is capable of generating novel text, video, images,
9 audio, and other media based on prompts or other forms of input provided
10 by a person.

11 **SECTION 3.** The Cybersecurity and Infrastructure Security Agency (CISA) will enforce
12 the implementation of this legislation:

13 A. No AI generated interactive computer service will be allowed to use
14 immunity claims for civil or criminal cases brought under Federal or
15 State law.

16 **SECTION 4.** This legislation will take effect on FY 2025. All laws in conflict with this
17 legislation are hereby declared null and void.

A Bill to Disincentivize the Use of Chemical Fertilizer

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Over a period of 20 years subsidies will gradually be
2 removed from farms that use chemical fertilizers and will be reformed into
3 a grant system for farms that adopt agroecology practices .

4 **SECTION 2.** Agroecology will be defined as practices that work with the
5 natural ecology of agricultural land to restore land degradation. Chemical
6 fertilizer will be defined as artificially manipulated substances containing
7 irregular quantities of nitrogen, potassium, or phosphorus.

8 **SECTION 3.** The USDA will be responsible for the enforcement of this
9 bill.

10 A. The USDA will be responsible for forming a grant system that properly
11 allocates the funding from previous subsidies between several farms
12 based on production.

13 B. The USDA will confirm the effectiveness of adopted agroecology
14 practices.

15 C. The USDA will compile and publish a list of disqualifying chemical
16 compositions within fertilizers

17 **SECTION 4.** This legislation will take effect on January 1 2025. All laws in
18 conflict with this legislation are hereby declared null and void.
