# A Bill to Require a Stronger Checks on National Emergencies to Protect Our Checks and Balances

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** To declare a National Emergency, 60% of both houses of Congress
- 3 must vote to approve the declaration of a National Emergency before the
- 4 President may exercise emergency powers.
- 5 SECTION 2. If Congress is in recess, the President may declare an Emergency for up
  6 to 30 days pending renewal by Congress. The declaration may not be renewed
  7 without Congressional approval. The President may not spend funds in excess of \$10
  8 million or enact permanent policy until Congress approves the emergency.
- 9 **SECTION 3.** This legislation will take effect immediately. All laws in conflict with this 10 legislation shall hereby be declared null and void.

### A Resolution to Mandate the Use of Public Defenders

- 1 **WHEREAS**, The 6th Amendment of the Constitution upholds the right to an attorney;
- 2 and
- 3 WHEREAS, In many cases, affluent criminal defendants can expect favorable
- 4 outcomes compared to impoverished criminal defendants who depend upon public
- 5 defenders; and
- 6 WHEREAS, It is more just that cases are determined on the basis of guilt or
- 7 innocence rather than quality of legal representation; now, therefore, be it
- 8 **RESOLVED**, That all criminal defendants should only be allowed to receive representation in the form of a public defender.

#### A Bill to Mandate the Use of E-Textbooks

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** The U.S. shall enact a law to mandate the usage of e-textbooks 3 in all U.S. schools instead of printed textbooks.
- 4 **SECTION 2.** The U.S. Department of Education will oversee the implementation of 5 this bill. The U.S. Department of Education will provide 50% of the funding to 6 schools to phase out printed textbooks and transition schools to the new e-textbook 7 format over a 5 year period.
- 8 **SECTION 3.** \$500 million dollars will be allocated from the U.S. Department of 9 Education's budget over a 5 year period to pay for the e-textbooks.
- 10 **SECTION 4.** This bill will take effect from the start of the 2025-2026 school year, All 11 laws in conflict with this legislation are hereby declared null and void.

# A Resolution to Establish a Department of Cybersecurity

- 1 WHEREAS, Cyberattacks are becoming increasingly easy to carry out; and
- 2 **WHEREAS**, Life supporting systems including hospitals and water filtration systems 3 are at risk of cyber attacks; and
- 4 **WHEREAS**, Russia has been able to compromise U.S. national security and 5 elections; and
- 6 **WHEREAS**, The economic costs due to cyberattacks ranges in the tens of billions; 7 now, therefore, be it
- 8 **RESOLVED**, That the Congress here assembled shall establish a new cabinet-level 9 department, titled the Department of Cybersecurity, responsible for preventing and 10 protecting the United States from cyberthreats and cyber attacks.

## A Bill to Implement Robotics in Understaffed Hospitals

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** The United States Department of Health and Human Services shall 3 make \$10 billion in grants available to understaffed public and nonprofit hospitals.
- 4 These grants will be used for the implementation of robotics at no cost to the facilities.
- 5 **SECTION 2.** "Robotics" is defined as systems that are able to operate autonomously 6 without direct human supervision.
- 7 **SECTION 3.** The United States Department of Health and Human Services shall 8 oversee the implementation of this legislation.
- 9 **SECTION 4.** This legislation will take effect on January 1, 2026. All laws in conflict 10 with this legislation are hereby declared null and void.

A Bill to Ban Red Light Cameras to Make American Roads Safer

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** The installation and use of red light cameras in the United States will be 3 prohibited.
- 4 **SECTION 2.** Red light cameras are defined as a traffic enforcement camera which is 5 capable of producing recorded images of motor vehicles entering an 6 intersection while the traffic light indicates a red signal.
- 7 **SECTION 3.** The United States Federal Highway Administration (FHA) in conjunction 8 with state agencies will oversee the implementation of this bill. The use of red light 9 cameras shall be fully phased out by five years after the date of passage.
- 10 Photographs and videos captured using red light cameras can no longer 11 be brought up as evidence before a jury.
- 12 **SECTION 4.** This legislation shall take effect immediately upon passage. All laws in 13 conflict with this legislation are hereby declared null and void.

# Bruin Novice Congress Docket October 19th, 2024 Round 3, Item 1

### A Bill for Federal Bail Reform

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** No judge in any court created by or under Article III of the Constitution of 3 the United States may use payment of money as a condition of pretrial release in any 4 criminal case for a "qualifying offense."
- 5 **SECTION 2.** A person charged with a qualifying offense who is released to await trial 6 in the community can be subject to bail or pretrial detention at a later point if he or she 7 persistently and willfully fails to appear in court, violates an order 8 of protection, is accused of witness tampering or intimidation, or is charged 9 with another felony while awaiting trial for a felony.
- 10 **SECTION 3.** "Qualifying offenses" is defined as misdemeanors and non-violent 11 felonies.
- 12 **SECTION 4.** This legislation will be implemented upon passage. All laws in conflict 13 with this legislation are hereby declared null and void.

## A Bill to Eliminate Stock Trading by Members of Congress

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** All members of the U.S. House of Representatives and the U.S. Senate 3 are prohibited from trading stock while in office.
- 4 **SECTION 2.** If a member of Congress violates this legislation, said 5 member will lose any leadership positions in Congress. Upon the second 6 violation, said member will lose any and all committee assignments. On the 7 third violation, said member will be expelled from Congress.
- 8 **SECTION 3.** Enforcement will be through the House and Senate Ethics committees.
- 9 **SECTION 4.** This legislation will take effect immediately. All laws in conflict with this 10 legislation are hereby declared null and void.

#### A Bill to Provide Student Loan Debt Relief to Teachers

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** Upon completion of a college degree, State Certified teachers, who work
- 3 in Public Schools, will be eligible for a Loan Forgiveness Program for their student
- 4 loan debt upon completion of a 4-year teaching contract.
- 5 **SECTION 2.** "Loan Forgiveness Program" will be defined as "a debt being completely 6 forgiven."
- 7 **SECTION 3.** The Department of Education and the IRS will oversee the enforcement8 of this bill. Any certified teacher who does not finish their 4-year teaching9 contract will have to personally pay back their student loans.
- 10 **SECTION 4.** This legislation will be enacted upon the day of passage.
- 11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
