Fostering American Industrial Revival (F.A.I.R.) ACT

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1**. The United States shall impose tariffs to protect domestic industries,

2 reduce reliance on foreign imports, and address trade imbalances. A 10% tariff shall

3 be imposed on all imported goods. A 20% tariff shall be imposed on imports

4 originating from nations with annual trade surpluses exceeding \$100 billion. A 60% 5 tariff shall be imposed on imports from non-compliant nations.

6 **SECTION 2**. For the purposes of this legislation, the following terms are defined:

7 A. "Tariff" means any tax imposed on imported or exported goods.

8 B. "Trade Surplus" means the amount by which a country's exports exceeds its 9 imports over a defined period.

10 C. "Non-compliant nation" means a country identified by the U.S. Trade

11 Representative as engaging in practices including but not limited to intellectual

12 property theft, forced technology transfer, or currency manipulation.

13 SECTION 3. The Department of Homeland Security will be responsible for tariff

14 collection at all U.S. ports of entry. The U.S. Trade Representative will be

15 responsible for tariff designations and updates on non-compliant nations engaging in 16 unfair trade practices.

17 **SECTION 4**. This legislation will take effect on February 1, 2025. All laws in conflict 18 with this legislation are hereby declared null and void.

WHEREAS, The Japanese people cannot rely on their government to secure
domestic tranquility in light of North Korean aggression and everlasting volatility; now,
therefore, be it
RESOLVED, by the Congress here assembled that the United States encourage
Japan to repeal Article 9 in order to look out for its well-being; and, be it
FURTHER RESOLVED, The United States Department of Defense shall assist the
Japanese Self-Defense Forces in developing an offensive military apparatus.

A Resolution to Recognize the Autonomy of Iraqi Kurdistan to Stabilize the Region and Promote Peace

1 WHEREAS, The Kurdish people in Iragi Kurdistan have long sought recognition of 2 their autonomy, but their status remains uncertain under Iraqi law; and 3 WHEREAS, The lack of formal recognition of Kurdish autonomy has led to ongoing 4 tensions between the Kurdistan Regional Government (KRG) and the Iragi central 5 government, exacerbating instability in the region; and 6 WHEREAS, This instability contributes to economic hardship, limits foreign 7 investment, and heightens the risk of conflict, negatively impacting not only the 8 Kurdish population but also the broader Middle East; and 9 WHEREAS, The formal recognition of Iragi Kurdistan's autonomy could strengthen 10 regional governance, provide a framework for resource sharing, and enhance 11 cooperation between the KRG and the Iraqi central government; now, therefore, be it 12 **RESOLVED**, That the Congress here assembled calls for the formal recognition of 13 Iragi Kurdistan's autonomy within the framework of the Iragi Constitution, to stabilize 14 the region and promote lasting peace; and, be it 15 **FURTHER RESOLVED**, That the United States government should encourage 16 diplomatic efforts and offer support to facilitate negotiations between the Kurdistan

17 Regional Government and the Iraqi central government to ensure the successful18 implementation of this resolution.

A Bill to Subsidize P.F.F (Pesticides Free Farming)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. In order to reduce the use of pesticides in food crops, the U.S. Federal
government will increase its subsidies to farmers for expanding their use of GMO
crops.

4 SECTION 2. The current subsidy will increase from a maximum of \$125,000 to

5 \$250,000 (per year) to aid in replacement of standard crops with GMO crops.

6 SECTION 3. Definitions:

7 Subsidy - A sum of money granted by the government to assist the industry.

8 GMO - A plant, animal, or microbe with one or more genetic changes.

9 Pesticides - A substance used for destroying insects or other organisms harmful to 10 plants.

11 Food crop - The crops that are cultivated through agriculture for the purpose of 12 feeding people.

13 **SECTION 4**. The U.S. Food & Drug Administration (FDA) will oversee the

14 disbursement of funding.

15 **SECTION 5**. This bill will take effect immediately upon passage. All laws in conflict 16 with this legislation are hereby declared null and void.

The Green Transition Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Over the course of three years, all federal subsidies currently allocated
to the fossil fuel industry shall be redirected to support renewable energy initiatives.
SECTION 2. Renewable energy is defined as energy derived from natural sources
that replenish without depletion. This includes, but is not limited to, solar, wind, and
hydroelectric power.
SECTION 3. The U.S. Department of Energy (DOE) and the Environmental Protection

7 Agency (EPA) will be responsible for implementing and overseeing the reallocation of 8 these funds.

9 SECTION 4. This legislation will take effect on January 1st, 2025

10 SECTION 5. All laws in conflict with this legislation are hereby null and void.
