# A Bill to Nationally Legalize Sports Betting

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:		
2	ARTICLE I	All forms of sports betting from national sportsbooks will be legal in the United	
3		States and its territories.	
4	ARTICLE II	RTICLE II A: Sports betting includes betting on all sports from national sportsbetting	
5		companies. Semi-professional sports are legal in all states.	
6		B: The federal government will impose a tax on sports betting of 15% on	
5		sportsbooks on top of the original state tax. Tax funding will be discretionary	
6		funding for Congress to allocate.	
7	ARTICLE III	The Department of Commerce will oversee the implementation of this	
8		legislation.	
9	ARTICLE IV	The implementation date of this bill will be September 1, 2024.	
10	ARTICLE V	All laws and regulations in conflict with this legislation will be hereby null and	
11		void.

### A Bill to Provide Americans a Living Wage

Be it enacted by Congress assembled that:

- **SECTION 1.** The Fair Labor Standards Act of 1938 is amended as follows:
- A. No employee shall be paid less than \$10.50 hourly, beginning on the effective date of
- 3 this act;
- **B.** No employee shall be paid less than \$12.00 hourly, beginning one year after the
- 5 effective date of this act;
- 6 C. No employee shall be paid less than \$13.00 hourly, beginning two years after the
- 7 effective of this act;
- 8 **D**. No employee shall be paid less than \$14.00 hourly, beginning three years after the
- 9 effective date of this act;
- 10 **E.** No employee shall be paid less than \$15.00 hourly, beginning four years after the effective date of this act;
- F. No employee shall be paid less than \$16.00 hourly, beginning five years after the effective date of this act;
- G. No employee shall be paid less than \$17.00 hourly, beginning six years after the effective date of this act.
- SECTION 2. This act shall take effect July 1, 2025

#### A Bill to Mandate That All Students are Required to be Formally Instructed on CPR Procedures

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- Section 1. The United States will allocate a combined 375,000,000 dollars to the Department of Education, the Department of Health, and the Department of Labor in order to educate all students on CPR procedures.
- Section 2. Students shall be defined as all school going children in grades 9th through 12th.
- The Department of Health will be allocated 110,000,000 dollars in order to buy the Red Cross Instructor Kits as well as other supplies and dispense them to all schools, both private and public, throughout the states. The Department of Labor will receive an allocation of 260,000,000 dollars in order to sufficiently pay all teachers under this program.
  - A. The Department of Education and the Department of Health will join together With a joint budgeting of 5,000,000 dollars in order to create the curriculum of the aforementioned program. The curriculum shall include per school, eight specially trained teachers, 2 per grade, that are required to teach a combined yearly total of 10 CPR instructing hours per year.
- Section 4. This bill will take effect in FY 2025.
- Section 5. All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Fund the Loess Plateau Watershed Rehabilitation Project

1	SECTION 1.	The United States shall provide funding to the International Development		
2		Association (IDA) in order for them to be able to continue and better		
3		construction on the current Loess Plateau Watershed Rehabilitation		
4		Project.		
5	SECTION 2.	A. The Loess Plateau Watershed Rehabilitation Project aims to boost		
6		agricultural production and incomes on 15,600 km² of land in the Yellow		
7		River's tributary watershed in China.		
8		B. The International Development Association (IDA) is the single largest		
9		provider of funds to economic and human development projects in the		
10		world.		
11	SECTION 3.	This legislation shall be enforced by the US Agency for International		
12		Development.		
		A. A \$500 million dollar annual fund shall be allocated to the US Agency		
		for International Development to fund the Loess Plateau Watershed		
		Rehabilitation Project until the project is finished.		
	SECTION 4.	1. This legislation will take effect at the start of FY 2026. All laws in conflict		
		with this legislation are hereby declared null and void.

# A Bill to Prevent Employers from Using Employees' Social Media Presence Against Them

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Employers will be prohibited from seeking employees' social media
2		accounts and using their media against them. Employees are not required
3		to give employers their personal social media to monitor their accounts.
4	4 SECTION 2. Social Media will be defined as any and all publicly made posts ma	
5		personal time and accounts.
6		Employees include all working and potential applicants in all regions of
7		work.
8	SECTION 3.	The U.S. Department of Labor shall oversee the enforcement and
9		implementation of this bill.
10		A. If caught in violation of this legislation, employers will be subject to a
11		fine of \$10,000, which will double for each subsequent violation.
12	SECTION 4.	This legislation will take effect in January 2025. All laws in conflict with this
13		legislation are hereby declared null and void.

7	SECTION 3.	The Department of Defense will collaborate with the	
8	Government Accountability Office to ensure that no future contracts will		
9	be established with Boeing.		
10	SECTION 4.	This legislation will be implemented immediately upon its	
11	passing.

	null and void.
