The Climate Change Compromise Act of 2024

1	BE IT ENAC	TED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1 .	The United States shall implement a carbon tax of \$50 per metric
3		ton of carbon emitted by large companies.
4	SECTION 2 .	A carbon tax shall be defined as a tax levied on the emission of
5		carbon through the burning of fossil fuels. Large companies shall
6		be defined as legal entities that emit greater than 10,000 metric
7		tons of carbon annually.
8	SECTION 3 .	The Department of Energy and the Internal Revenue Service shall
9		be in charge of overseeing and implementing this legislation.
10		A) The Department of Energy (DOE) shall independently record
11		emissions produced by large companies.
12		B) The Internal Revenue Service (IRS) shall collect the tax
13		accordingly. Companies who fail to comply shall be fined an
14		additional \$50 per metric ton of carbon on which they failed to
15		pay taxes.
16		C) Tax revenue shall be allocated to the Department of Energy's
17		budget to connect existing renewable energy sources to the
18		national power grid.
19	SECTION 4 .	This legislation will take effect on July 1, 2025. All laws in
20		conflict with this legislation are hereby declared null and void.

1	WHEREAS,	The Joint Comprehensive Plan of Action, or JCPOA, was an
2		effective denuclearization agreement between the United States
3		and Iran; and
4	WHEREAS,	The United States left the JCPOA in 2018 despite Iran upholding
5		its terms of the agreement; and
6	WHEREAS,	The international community, the United Nations, and American
7		international relations scholars regret the United States' choice to
8		leave the JCPOA; and
9	WHEREAS,	Iran's denuclearization is critical to regional stability and
10		international involvement in humanitarian activities in the Middle
11		East; and
12	WHEREAS,	Rejoining the JCPOA now would correct the course of American
13		foreign policy in the Middle East, fostering cooperation and
14		de-escalating nuclear tension; now, therefore, be it
15	RESOLVED,	By the Congress here assembled that the United States rejoin the
16		Joint Comprehensive Plan of Action with Iran.

A Resolution to Rejoin the Joint Comprehensive Plan of Action (JCPOA)

A Bill to Enact Presumed Consent for Organ Donation

1	BE IT ENACT	TED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The United States shall presume consent for organ donation upon
3		a citizen's death unless otherwise specified.
4	SECTION 2 .	At the time of filing federal forms or applying for or renewing an
5		identification card, the applicant shall be deemed to have
6		consented to anatomical donation of his or her organs and tissue
7		upon the determination of the applicant's legal death, unless the
8		applicant expressly elects not to be an organ tissue donor.
9		A. Legal guardians of citizens under 18 can opt out for dependents.
10		B. The Health Resources and Services Administration shall utilize
11		\$10 million to go towards a public education program. The
12		program shall alert the American public of the change in the
13		system as well as educate the public on what organ donation is,
14		what presumed consent means, etc.
15	SECTION 3 .	This legislation will be overseen and enforced by the Health
16		Resources and Services Administration (HRSA).
17	SECTION 4.	This legislation will take effect on July 1, 2025. All laws in
18		conflict with this legislation are hereby declared null and void.

A Bill to Abolish the Refugee Admissions Cap

1	BE IT ENACT	TED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1 .	There will no longer be a cap on how many refugees the United
3		States Citizenship and Immigration Services (USCIS) may admit.
4		The refugee admissions cap will no longer be used to determine
5		how many refugees may enter the country.
6	SECTION 2 .	The refugee admissions cap is defined as the limit placed on how
7		many people may be granted asylum as refugees in the United
8		States, determined by the executive branch.
9	SECTION 3.	The United States Citizenship and Immigration Services (USCIS)
10		will oversee this legislation.
11	SECTION 4 .	This legislation will take effect on January 1, 2025. All laws in
12		conflict with this legislation are hereby declared null and void.
