Dear Forensics Community:

The forensics teams of TCU and UTD invite you to the DFW Swing, to be hosted on the beautiful sunny campus of The University of Texas at Dallas, October 4-6, 2024.

We invite you to join us for a weekend of competition featuring two complete individual event tournaments with the eleven AFA events, and an IPDA debate tournament. Each individual event tournament (UTD Invitational on Saturday and TCU Invitational on Sunday) will include two preliminary rounds and a final (semi-finals if necessary). IPDA will have five preliminary rounds over Friday afternoon and Saturday, and out-rounds as needed on Saturday. IPDA will include novice, JV, and varsity divisions if warranted by entry sizes of each event. Divisions may be collapsed if small entry sizes warrant.

Students may enter three individual events per pattern, or one IE per pattern plus IPDA on Friday and Saturday, and up to three individual events per pattern on Sunday. Two duos counts as two events.

Further details about the DFW Swing follow on the next few pages. We look forward to receiving your entry by the deadline: Tuesday, Oct. 1 at 5:00 p.m. through Speechwire. Please visit their website to enter.

We are asking teams to please cover their judging entries, particularly in IPDA. We will have a limited number of hired judges, but request school coverage of all entries. We will use electronic balloting for IE, so IE judges should bring laptops or other internet connected devices.

We can't wait to welcome you to Dallas in October!

Entry Deadline: Entries should be sent no later than 5:00 on Tuesday, October 1. Entries may be submitted through Speechwire. Drops and changes may be made without penalty until Wednesday, October 2 at 5:00. Changes after this time will incur an additional fee of \$10 per slot.

Debate Limitations: Students may enter only one IE per flight with IPDA on Saturday. Students entered in both debate and IE will be responsible for making it to rounds, and will go to IPDA first unless otherwise specified in draw. The tournament directors reserve the right to collapse divisions of debate if entry size warrants, and to flight divisions. Debate divisions offered: IPDA Varsity, JV, Novice.

Individual Event Limitations: Students may enter a maximum of three individual events per pattern, or one IE per pattern plus IPDA. Competitors may enter two duos (with different partners), but this will count as two events in pattern A. Students entered in multiple events will be responsible for making it to their rounds on time, and should endeavor to sign in. The tournament directors reserve the right to limit the number of entries from a school, and to balance rounds to accommodate judging obligations from schools with large entries. We will use electronic balloting for IE, so judges should bring laptops or other internet connected devices.

Event Rules

We will follow AFA rules for individual events. Open internet access will be allowed in extemp prep and IPDA.

IPDA debate will follow IPDA guidelines. Debaters will be given 30 minutes of preparation time following topic draw. Debaters are expected to be in their competition rooms at the end of prep time, and a late forfeiture rule will be enforced. IPDA may be flighted if space and judge conservation is warranted by entry sizes. Students are responsible for making it to draw on time.

Fees

Fees will be assessed on Wednesday, Oct. 25 at 5:00. Drops or changes after that point will incur both the assessed fee and a \$25 nuisance charge.

Individual Events: \$10 (one judge covers 6 slots)
Judging Fee Per Uncovered Individual Event slot: \$15
IPDA: \$15 (one judge covers four debaters)
Judging Fee Per Uncovered IPDA entry: \$15
Drops after Wednesday: fee + \$10. Dropped judges at registration: \$50 each.

Awards

Awards will be given to the top six competitors in each individual event, and out-round participants in debate. Debate events will also include speaker awards for the top 3 speakers in each division. The top novice competitor in each category will also be recognized in IE events.

Individual Sweepstakes: The top three individual students in individual sweepstakes will receive an award. Eligibility requires students to compete in three events, which may include a mix of IPDA and IE.

Team Sweepstakes: The top three schools will be recognized with an award for individual events sweeps, debate sweeps, and combined debate/IE. Sweepstakes awards will be calculated with the following formula:

Individual Event Preliminaries:

1st – 3 points
2nd – 2 points
3rd – 1 point

Individual Event Finals:

1st – 12 points
2nd – 10 points
3rd – 8 points
4th – 6 points
5th – 4 points
6th – 2 points

Debate Preliminaries:

Win – 3 points

Debate Out-Rounds (except finals):

Win – 6 points
Loss – 2 points

Debate Finals:

Win – 12 points
Loss – 6 points

Tournament Practices

Host schools may enter novice competitors in their own half of the IE swing, but these students will be ineligible for individual sweeps. Host school competitors will be entered in debate. Tournament directors reserve the right to place students from the same team into the same section of IEs to conserve judges if necessary.

Registration and parking information will be sent to attending schools before the tournament.
