A Bill to Ban Subscription Based Services

Be it enacted by the Congress here Assembled that:

- 1 **SECTION 1** Businesses may no longer practice a business model that includes
- 2 customers paying for a subscription service.
- 3 **SECTION 2** A "subscription service" is defined as a collection of recurring revenue for a
- 4 product or service.
- 5 **SECTION 3** Should a business not comply with the terms of the ban, their practice and
- 6 revenues will be suspended until it complies.
- 7 Credit card services shall not be banned.
- 8 **SECTION 4** The Bureau of Economic and Business Affairs shall oversee the evaluation
- 9 of the adherence of the ban and the suspension of said businesses.
- 10 **SECTION 5** The legislation shall take effect on January 1st, 2026.
- 11 **SECTION 6** All laws and order in conflict are hereby declared null and void.

B

A Bill to Allow Military Spouses to Obtain Teaching Licenses When Moving to Different Duty Stations

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** Military spouses will be able to obtain a teaching license
2 when they are moved by the military to a different state.
- 3 **SECTION 2.** Military spouses are defined as a military wife or husband of
4 a veteran, active duty, reserved, or national guard military personnel.
- 5 **SECTION 3.** This legislation will be a collaborative oversight by the
6 Department of Defense and the United States Department of Education.
- 7 A. The current memorandum of understanding between the Department
8 of Defense and the United States Department of Education supports
9 the quality of education and the unique challenges faced by military
10 families.
- 11 B. States will agree to a period of teacher certification reciprocity not to
12 exceed two years. Teachers exceeding two years at the same duty
13 station will be required to meet licensing standards of that state.
- 14 **SECTION 4.** This legislation will take effect on January 1, 2025. All laws
15 that conflicts with this legislation are hereby declared null and void.

C

A Bill to Limit the Brightness of Headlights

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States Congress shall pass a law limiting the brightness of
2 headlights on any manufactured vehicle to no more than 2,000 lumens, to ensure the safety
3 of drivers.

4 **SECTION 2.** Those drivers found not in compliance with this law will be issued a
5 correctable violation. If it is not corrected, drivers will be charged a fine of \$1 per every
6 lumen over the limit. In addition, a \$1,000 fine will be charged to manufactures per vehicle
7 produced with illegal headlights.

8 **SECTION 3.** This legislation will be overseen by the Department of Transportation.

9 **SECTION 4.** This legislation will go into effect January 1, 2028.

10 **SECTION 5.** All laws in conflict with this law are hereby declared null and void.

A Bill to Lower the Legal Drinking Age in Colorado to 18

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** The legal drinking age in Colorado shall be set at 18 years of age.
- 3 **SECTION 2.** The Colorado Liquor Code shall be updated to reflect this change and allow
4 for the possession and consumption of alcohol for all persons 18 years of
5 age and above.
- 6 **SECTION 3.** The Colorado Liquor Enforcement Division will oversee the implementation
7 and execution of this legislation. The division is already provided with the
8 funds necessary to enforce this legislation.
- 9 A. Any space that serves or sells alcohol with an off-premise or on-premise
10 liquor license, including but not limited to Restaurants, Grocery Stores,
11 Convenience stores, liquor outlets, etc., will be legally required to serve
12 any person of 18 years of age or older with a legitimate form of
13 identification.
- 14 B. Failure to comply with this legislation will result in a fine between \$500
15 and \$5,000.
- 16 **SECTION 4.** This legislation will take effect on January 1st, 2026
- 17 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

E

A Bill to Ban Religious Materials in Hotels

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** Hotels will no longer be permitted to place printed religious materials in rooms
2 designated for sleeping, and common areas.

3 **SECTION 2.** Hotel shall be defined as an establishment that provides sleeping accommodations.
4 Printed religious material shall be defined as any religious text or other writing that has
5 been printed, such as books, pamphlets, or sermons. Common areas shall be defined
6 as a portion of the building that is generally accessible to all occupants.

7 **SECTION 3.** Hotels who are found to be in noncompliance shall be fined \$1,000 for each piece of
8 printed religious material found on a monthly basis.

9 **SECTION 4.** The US Department of Commerce will oversee the enforcement of this bill.

10 **SECTION 5.** This legislation will take effect on January 1, 2025.

11 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

A Constitutional Amendment to Lower the Voting Age

1 **RESOLVED,** By two-thirds of the Congress here assembled, that the following article is
2 proposed as an amendment to the Constitution of the United States, which shall
3 be valid to all intents and purposes as part of the Constitution when ratified by
4 the legislatures of three-fourths of the several states within seven years from the
5 date of its submission by the Congress.

7 **Article –**

8
9 **SECTION 1.** The voting age for US Citizens will be lowered to 16 years of age in local,
10 state and national elections.

12 **SECTION 2.** US citizens shall be defined as outlined in the constitution as anyone born
13 or naturalized in the United States and under the national government's
14 jurisdiction.

16 **SECTION 3.** The Congress shall have power to enforce this article by appropriate legislation.
