

# A Bill to Create the Transpacific Security Organization to Counter Chinese Expansionism

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States will create the Transpacific Security Organization (TSO) to  
2 formally counteract Chinese expansionism and intimidation in Asia. The TSO  
3 will follow a collective defense principle to counter any Chinese intimidation  
4 or invasion onto the territorial integrity of the nation.

5 **SECTION 2.**

6 **A.** The TSO will follow a collective defense principle where any acts of war  
7 from a non-member state onto a member will result in a joint defensive  
8 response to defend the ally nation and ensure its self-determination.

9 **B.** The founding members of the organization will consist of: Japan, Australia,  
10 Taiwan, South Korea, and the United States of America. Any further expansion  
11 of the organization will require consensus from  $\frac{3}{4}$  of the member states for  
12 admission.

13 **C.** In the case of Chinese expansionism in the South China Sea or intimidation  
14 of member states, the TSO will convene to decide on the official course of  
15 action by all members.

16 **D.** Joint defensive response will be defined as any economic and military  
17 measures to protect the full territorial integrity of a nation, including, but not  
18 limited to economic sanctions, arms shipment, and deployment of military  
19 force.

20 **SECTION 3.** The United States Department of Defense (DOD) will oversee enforcement  
21 along with the specific enforcement mechanism. The DOD will collaborate  
22 with the founding members to formalize this organization and enter into a  
23 collective defense treaty according to this legislation.

24 **SECTION 4.** This legislation will take effect immediately upon passage. All laws in conflict  
25 with this legislation are hereby declared null and void.

# A Bill to Restrict the Use of Artificial Intelligence technologies in Healthcare

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Artificial Intelligence and Large Language Models are hereby banned from  
3 use in healthcare settings unless a human operator retains decision-making  
4 control at every step of the process. Under no circumstances should the  
5 aforementioned technologies be implemented without proper controls.

6 **SECTION 2.** “Artificial Intelligence” is defined as any technology which makes  
7 autonomous decisions without human input. “Large Language Models” are  
8 defined as any chatbot technology that can process natural language and  
9 autonomously generate a response.

10 **SECTION 3.** Enforcement of this bill will be delegated to the Department of Health and  
11 Human Services. Healthcare entities found to be in violation of this bill will be  
12 fined no less than \$10,000 per violation.

13 **SECTION 4.** This legislation will take effect immediately after passing. All laws in conflict  
14 with this legislation are hereby declared null and void.

# The C.U.R.E. Act (Cuban Unity and Revitalization Efforts)

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Cuban businesses and the nation's economy face significant challenges in  
3 the absence of American tourism and trade. To help strengthen the  
4 Cuban economy, all sanctions and embargoes on Cuba will be removed.  
5 This will include legislation implementing them, such as the Helms-Burton  
6 Act. Such legislation will be removed in its entirety permitting American  
7 citizens to travel and spend in Cuba freely.

8 **SECTION 2.** A) Sanctions and embargoes shall be defined as restrictions on  
9 international commerce and international business.

10 B) The Helms-Burton Act is officially known as the Cuban Liberty and  
11 Democratic Solidarity Act of 1995.

12 **SECTION 3.** The Office of Foreign Assets Control and the Department of Treasury will  
13 oversee the implementation legislation.

14 **SECTION 4.** This legislation will take effect one year after passing. All laws in conflict  
15 with this legislation are hereby declared null and void.

# A Resolution to Expand Educational Equality (EEE)

**WHEREAS**, millions of students attend American colleges and universities each year;  
and

**WHEREAS**, the cost of higher education is rising at an unprecedented rate; and

**WHEREAS**, students of all income levels can no longer rely on private colleges and  
universities to provide them with affordable education opportunities; and

**WHEREAS**, the cost of attendance for many colleges and universities, both public and  
private, can be extremely difficult to calculate, leading to poor  
financial decisions; and

**WHEREAS**, automatic merit-based scholarships for public colleges and universities  
have been implemented in certain states, using a number of objective  
educational standards, including but not limited to: GPA, SAT/ACT scores,  
and community service hours; and

**WHEREAS**, such programs have led to an increase in positive financial and educational  
outcomes for minority and low-income students; now, therefore be it

**RESOLVED**, That the Congress here assembled work with the Department of Education  
and state governments to establish and fund automatic merit-based  
scholarships for public colleges and universities using state-chosen  
standards.

**FURTHER RESOLVED**, That such increase in automatic merit-based scholarship funding  
shall not reduce spending on need-based financial aid programs for public  
colleges and universities.

# A Bill to Fund Roads through EV Engagement

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** A tax shall be levied on Electric Vehicles (EVs) to compensate for their  
3 non-contribution to gasoline taxes that fund road infrastructure.

4 **SECTION 2.** "Electric Vehicles (EVs)" shall refer to any vehicle that uses an electric  
5 motor for propulsion and is powered by electricity from external sources.  
6 The "tax" shall be an annual fee, calculated to be equivalent to the  
7 average gasoline tax paid by internal combustion engine vehicles.

8 **SECTION 3.** The Department of Transportation (DOT) shall oversee the  
9 implementation and enforcement of this tax. The DOT will develop a new  
10 system for EV owners to report their vehicle type and annual mileage,  
11 and will collect the tax accordingly. Penalties for non-compliance shall  
12 include fines and registration holds.

13 **SECTION 4.** This legislation will take effect on August 1, 2025. All laws in conflict with  
14 this legislation are hereby declared null and void.

# A Bill to Improve Saudi Humane Intervention Endeavors and Logistics Domestically (S.H.I.E.L.D. ACT)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States shall hereby formally initiate negotiations for the formation  
2 of a defense pact with Saudi Arabia, whereas the specificities of the pact  
3 itself shall be set through the aforementioned future negotiation.

4 **SECTION 2.** A. A defense pact shall be defined as a mutually agreed-upon set of  
5 conditions pertaining to the reciprocal military defense of both involved  
6 nations.

7 B. It shall be clearly established in any and all negotiations that the premise  
8 of nuclear mutually ensured destruction will not be a factor in any possible  
9 defense pact.

10 C. In order to initiate the negotiation procedure, the Saudi Arabian Ministry  
11 of Defense must first acknowledge and accept that the United States reserves  
12 the right to withdraw from the negotiation of the defense pact at any time  
13 without retaliation, or else risk political and economic isolation.

14 **SECTION 3.** The US Department of State in conjunction with the US Ambassador to Saudi  
15 Arabia shall be responsible for the implementation and oversight of this bill.

16 **SECTION 4.** This legislation shall be implemented immediately upon passage.

17 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
